# **CHRONOLOGY**

Formation of the Malayan Library Group on 25 March 1955. 1955 1958 Name changed to Library Association of Malaya and Singapore. 1960 Association dissolved and 2 new groups formed due to the Federation government's policy not to grant registration to pan-Malayan associations: Persatuan Perpustakaan Tanah Melayu (Library Association of Malaya) Library Association of Singapore 1964 Library Association of Singapore was reconstituted as Library Association of Malaya, Singapore Branch, after the merger between Singapore and Malaya. 1966 The Singapore Branch became an independent body after Singapore's separation from Malaysia. The Persatuan Perpustakaan Singapore (Library Association of Singapore) was formed. 1972 The Association was renamed the Library Association of Singapore (LAS) on 25 March 1972. The Association celebrated its Golden Jubilee on 15 November 2005. 2005 2007 The Association held its conference on the theme *Librarians*, Strengthening, Moving Forward from 29 to 31 January 2007. The Association accorded Mrs Hedwig Anuar the first LAS Lifetime Contribution Award on 1 November 2007. 2008 The Association gave out the LAS Professional Service award to 3 winners: Ms Lau Siew Kheng, Ms Manijeh Namazie and Mr R Ramachandran, at the Istana Reception on 9 May 2008. The Association held its LAS Conference 2008 on the theme Innovate to Serve on 8-9 May 2008. The LAS Professional Development Scheme was launched on 25 Aug 2008. 2009 136 LAS professional members from the first 5 batches were given the Practicing Professional award under the PDS scheme. The Association accorded the LAS Professional Service Award to Mrs

This was the first of the 5 competency based programmes which form the WSQ Higher Certificate in Library and Information Services. All 5 modules were developed by LAS and approved by WDA by end 2010.

Hence it is with great excitement that we await the coming flagship event of the library world – the International Federation of Library Associations' (IFLA's) World Library and Information Congress (WLIC) to be held in Singapore in August 2013. Much of the year for LAS has been spent in preparation for the events of the WLIC.

A strong Singapore contingent waved their flags at the 2012 Congress in Helsinki and LAS put together an inspiring video of the best of Singapore's libraries and librarians. The video was scored by a theme song composed by Singaporean librarian Ivan Chew and entitled Free. "Free" expresses how librarians and libraries can set the hearts and minds of users free.

I would like to thank my tireless Council Members who in this year had to juggle both the activities that come with any LAS year as well as the major events and outcomes we are planning for WLIC 2013. It has been a demonstration of what it means when people come together to work for something because of an indefatigable sense of belief in what a profession can do.

I would also like to thank the LAS Awards Panel and the Professional Development Scheme (PDS) Board for continuing their inspired work in highlighting the great professional work of librarians.

As I end my term, I wish the next President the very best in continuing to show the rest of the world what we already know – and that is, that librarians make sense, and that it makes sense to have librarians in a world that is somehow becoming a little harder every day to grasp and make sense of.

# **MEMBERSHIP**

The table below gives the membership status as of 31 December 2012. Total membership remained stable. The increase in professional and institutional (School Libraries) members balanced the dip in associate membership.

For the 2013 membership renewal exercise, based on positive feedback from members in 2012, \$20 Kinokuniya vouchers were again offered to the first 100 personal members to renew. As of 31 January 2013, all vouchers had been redeemed and 60% of the personal members had renewed their membership.

## **FINANCE**

The 2012 audited financial statements are presented in Appendix C, which comprise the balance sheet as at 31 December 2012, the statement of comprehensive income and expenditure, statement of changes in fund and cash flow statement for the year then ended, a summary of significant accounting policies and other explanatory information.

The total comprehensive income for the year after tax is \$45,327 compared to \$26,177 in 2011. The main sources of income were Training/Workshop Fees (\$69,140), Sponsorship (\$33,000), Events/Programs\* (\$32,302), and Membership Fees (\$31,150).

The main expenditure items in 2012 were for Training/Workshop (\$62,406), Events/Programs\* (\$27,752), Awards and Sponsorship (\$11,165), and Annual General Meeting (\$7,149).

The increase in income could be attributed to a number of factors. First and foremost was the decrease in total training expense from \$80,513 to \$62,406. The course development fee was very much reduced as most of the training courses under the WDA program had been developed and paid for in 2011. Lower venue cost, thanks to concessions from fellow member institutions, also resulted in much savings. The Training and Development Committee kept up their pace in organizing training courses and workshops, thus benefiting more than 200 trainees and resulting in more takings. Increased income from sponsorship and advertisement made up the balance.

Trade receivables past due also dropped significantly from \$13,168 in 2011 to \$6,420 in 2012. This is due to better communication between the Treasurer and respective Committee Chairs, as well as increased engagement from the Training and Development, Business and Development, and Membership Committees with institutions, sponsors and members to ensure prompt payment owed to the Association.

# **ANNUAL GENERAL MEETING 2012**

- 1. The AGM 2012 was held at The Pod, National Library Building, Singapore, on 12 May 2012 (Saturday). 86 members attended the meeting.
- 2. The minutes of the previous AGM were passed with no further amendments.
- 3. The AGM received and approved the Annual Report for the year ending March 2012 and the audited accounts for the Financial Year ending December 2011.

# **COUNCIL MEETINGS**

- The Council held 7 Council meetings on 20 April 2012, 15 June 2012, 24 August 2012, 19 October 2012, 14 December 2012, 15 February 2013 and 26 April 2013.
- 2. **Emerald arrangement.** Emerald has proposed a continuation of the same arrangement. Council agreed to this continuation and the new contract deal commenced and will terminate on 31 December 2013.
- 3. IFLA 2013. Three projects for the upcoming IFLA 2013 were proposed, i.e. a Video to promote Singapore Libraries, a special publication on the libraries and librarians of Singapore and an LAS Awards presentation to be graced by the President of Singapore for IFLA 2013. The Video project was completed in August 2012 and broadcasted at WLIC 2012 at Helsinki and other conferences in the World. The other two projects are scheduled to be completed by WLIC 2013.
- 4. **PDS Board and Working Committee**. Council approved the formation of the new PDS Board Standing Committee with the PDS Working Committee as its sub-committee.
- 5. **Membership benefit.** Council approved the proposal to purchase Kinokuniya vouchers as a 2013 membership benefit. The vouchers would be offered to the first 100 LAS personal members who renew their membership for 2013.

#### 1. Business Development Committee

- 1.1 The team worked on getting sponsorships for the Librarians for Tomorrow 2012. The event received support from 21 sponsors, namely, 3M Technologies, Cambridge University Press, Civica, Cxrus Solutions, EBSCO Publishing, Emerald, FE Technologies, Infohost, Kinokuniya, Micrographics Data, OneSource, OverDrive, Oxford University Press, ProQuest, SAGE Publications, Springer, Swets, Taylor & Francis, Wiley Blackwell, World Scientific, and YBP Library Services.
- 1.2 The team also sought sponsorship for the launch of the LAS commemorative publication on 18th August 2013. As of 26th April 2013, the event received support from 15 sponsors, namely, AAAS/Science, Cambridge University Press, Cengage Learning, EBSCO Publishing, IEEE, Infohost, Micrographics Data, Oxford University Press, ProQuest, SAGE Publications, Springer, Taylor & Francis, Thomson Reuters, Wiley Blackwell, and World Scientific.
- 1.3 During the 2012 Annual General Meeting, members voted logo number 1 as the new logo for LAS. As a final step, LAS members will be asked to vote for their preferred font for the logo during the 2013 Annual General Meeting.
- 1.4 To maintain a consistent corporate image, the team drafted the LAS Logo Usage Guide, which has been approved by the 2011/13 Council.
- 1.5 A new webpage called "Support Us" was created on the LAS website, to highlight advertising and sponsorship opportunities with LAS. In addition, new spaces have been added for various banner advertisements.
- 1.6 The application configuration and settings of our online store, called "LAS Store", are being finalized.
- 1.7 The committee has developed partnerships with the following vendors and organisations:
  - a) Emerald has given all LAS members access to its LIS collection. All LAS members receive monthly emails about the top downloaded articles from the LIS collection. In return, Emerald is given publicity opportunities in LAS events.
  - b) HKTDC Hong Kong Book Fair offered LAS members complimentary hotel accommodation and admission tickets. Unfortunately, no one took up the sponsorship.
  - c) LAS assisted The Association for Information Management (ASLIB) to announce their MasterClass held in Singapore.
  - d) LAS provided free publicity for IFLA 2013 via our website and social media channels.

### 2. Information Technology Committee

- 2.1 We launched LAS Community Online portal, located at http://connectme.sg. Seven groups have been created (1) Arts Librarians, (2) Business Librarians, (3) Council of Chief Librarians, (4) Digital Librarians, (5) LAS Conference, (6) LAS Council and (7) LAS T&D group. More than 100 LAS members have joined these groups.
- 2.2 We upgraded and maintained the current web architecture that consists of Linux, Apache, Mysql and Php, including the application like Wordpress, eforms and the email system to be operationally ready and to protect from malware and downtimes.
- 2.3 We worked with a vendor and produced an MTV video for IFLA WLIC 2013 Singapore. This was screened at the closing ceremony of WLIC 2012
- 2.4 Statistical reports of the LAS Website show an increase in visitorship, an average of 2,500 visitors per month.

#### 3. Membership Committee

3.1 The Membership Committee organized the networking event "What Makes a Librarian?" – When Librarians Meet on Friday the 13<sup>th</sup> in April 2012. Over 90 librarians and information professionals from different institutions gathered to brainstorm about what it means to be a librarian and to put the context of being a librarian to the current changes that has happened around us. A SWOT (Strength, Weaknesses, Opportunities and Threat) analysis was done during the session and the key points captured in the Singapore Libraries Bulletin: http://www.las.org.sg/wp/sjlim/2012/11/finding-out-what-you-want-and-what-makes-a-librarian/.

- 3.2 The committee did a review of the membership application and renewal forms. The membership pages on the LAS website were updated in December 2012 with the revised forms. A new 'Personal Membership Update of Particulars' online form has been introduced. Membership benefits have also been added to the webpages.
- 3.3 A briefing was held for the new batch of MSc (Information Studies) students from NTU in October 2012. Held annually, this talk introduces LAS to the students and encourages them to join the association. Highlights include the LAS Library School Scholarship award.
- 3.4 See section on "Membership" for details of membership figures.

#### 4. Programmes and Social Committee

- 4.1 A total of 8 visits were organized by the Programmes & Social Committee from April 2012 to Apr 2013. The visits were a plethora of sorts ranging from museums, vendor-based sessions to exhibitions. For the latter, a collaboration with NLB brought about a tour of the Raffles Letters Exhibition and 2 other exhibitions for LAS members in November 2012. Other interesting visits included the Peranakan Museum, LTA Gallery and Heritage Conservation Centre.
- 4.2 The year ended with two visits to the recently opened Library@Chinatown, which showcased a public library with a niche collection.
- 4.3 See section on "Activities of the year" for details.

#### 5. Publication Committee

- 5.1 The 41<sup>st</sup> issue of SJLIM (Singapore Journal of Library and Information Management) 2012 was published electronically in Feb 2013. - 5.2 The Editorial Board for 2012 comprised Yit Chin Chuan of NLB/RP (Editor), Associate Professor M. Shaheen Majid of NTU and Yeo Pin Pin of SMU (Associate Editors), Associate Professor Chris Khoo of NTU, Choy Fatt Cheong of NTU, Idris Rashid Khan Surattee of SPH and Gulcin Cribb of SMU (Members).
- 5.3 The Singapore Libraries Bulletin (SLB) blog has monthly updates and we have begun to see some of our members contributing articles to this blog. The publications committee would like to thank our contributors and would like to encourage all members to actively share news about their libraries, their activities and/or about themselves to the rest of LAS.
- 5.4 The current SLB blog is supported by the following team: Yit Chin Chuan NLB/RP (Editor), Hilary Ho of NIE, Justin Tan of NYP and Ruby Seng of NUS (members).

- 5.5 WLIC2013 publications project. For the upcoming IFLA 2013 event, LAS plans to launch a book publication featuring our librarians. The title of the book is called "In 99 Words: Stories Librarians Tell". The team wanted to present a slice of the experiences from the many librarians we have in Singapore. To date we have collected 95 stories and will continue to add more till the final cut-off date in preparation for printing. More stories are welcomed as LAS is committed to publish them as digital copies on our webpage. Beside the print publication, LAS is planning to set up a webpage featuring the Libraries and Librarians in Singapore. We will be launching an appeal to all librarians and libraries in Singapore to provide basic information about themselves so they can be presented on these webpages. The print version will also be highlighting these webpages to draw attention of our international counterparts to our libraries and librarians in Singapore.

#### 6. Special Libraries Section Committee

- 6.1 The SLS Committee held 3 meetings during this period; 10 August 2012, 24 September 2012, and 19 March 2013.
- 6.2 The Special Interest Groups (SIGs) have continued to provide a valuable platform for networking and sharing among librarians and other like-minded individuals on the topics of the Arts, Business, Digital Libraries, Law, and more recently, Instruction and Training. As the demands of the workplace multiply and people find it increasingly more difficult to come together for meetings, the SIGs play a vital part in keeping people virtually connected. Currently there are five SIGs:
  - Arts Librarians Group for people from the arts libraries and arts institutions.
  - Business Librarians Group for anyone interested in promoting communication and cooperation among business information professionals.
  - Digital Librarians Group for anyone with an interest in digital library developments.

- Law Librarians Group for those involved in legal research and legal information management.
- Instruction and Training Group (working title) a newly formed group for those with a passion for instruction and training.
- 6.3 The 3<sup>rd</sup> Annual Networking Event was held at The Pod, National Library Building, on 1 November 2012. Sponsored by LexisNexis, as in previous years, four guest speakers shared their thoughts and experiences on the subject of *How Libraries Adapt to Change*.
- 6.4 The proud recipient of the 2012 Special Librarian Passion Award went to Rajendra Munoo who is Head of Learning and Information Services and Business Research Librarian at the Li Ka Shing Library at SMU. Actively involved in Singapore libraries for more than a decade, he is a strong advocate for the enrichment of the patron's experience of libraries. Rajendra was instrumental in kick-starting the Special Interest Group for instruction and training, generating interest by organizing the Information Literacy Seminar "Let's talk about evaluation, impact, outcomes, value, assessment and the student learner today" on 20 July 2012.

c) Effective from 2013, the course fees for the 2-day courses have been revised from \$330 to \$360. The course fees for the 3-day course remains the same at \$495. The revision of the course fees are made with consideration of the kind sponsorship from NUS Libraries and Temasek Polytechnic Library for the use of their computer labs for the Support General Reference and Enquiry Works and the Support Bibliographic Control Works modules.

#### 7.2 Professional Staff

The following courses were organized for the professional staff:

- a) "Citation, Journal Impact Factor and H-Index as Indicators of Research Performance" conducted by Prof. Szarina Abdullah (Principal Consultant, Wisdom Synergy Enterprise) on 5 & 6 July 2012. The course was held at NUS Central Library and was attended by 30 participants.
- b) "Performance Indicator for Academic Libraries" conducted by Prof. Sebastian Mundt (Stuttgart Media University) on 6 7 November 2012. The course was held at NUS Central Library and partially sponsored by Goethe-Institute. It was attended by 34 participants.
- c) T&D Chair is part of the working group planning the "Asian Library Leadership Certificate Program" to be offered by SMU. The information brochure is targeted to be ready in time for promotion during the WLIC 2013. The target date for the first run of the programme is April 2014.

#### 8. LAS Awards Panel

- 8.1 This is the Panel's 6<sup>th</sup> consecutive year to oversee the Association's effort to honour its members.
- 8.2 Six awards were under the care of the Panel during this period of review. The distribution of some of the awards moved from the usual January LAS event to a future date when IFLA will be held.

#### 8.2.1 LAS Lifetime Contribution Award 2013

Preparation is ongoing for the naming of our next Lifetime recipient at the upcoming LAS AGM 2013.

This award honours a retiree who has significantly contributed to the development of the library profession in Singapore and who has represented Singapore on an international level. It is awarded only when the Council identifies a worthy recipient.

#### 8.2.2 LAS Professional Service Award 2013

Preparation is ongoing for the naming of our next Professional Service Award recipient at the upcoming LAS AGM 2013

Criteria for this award include active LAS membership, strong leadership in the profession and significant contributions to the profession.

#### 8.2.3 LAS Outstanding Newcomer Award 2013

Preparation is ongoing for the naming of our next recipient at the LAS AGM 2013

This award seeks to recognize the accomplishments of outstanding newcomers to the library profession and to encourage outstanding contributions throughout their career.

#### 8.2.4 LAS Library School Scholarship 2012

One of the highlights each year is to provide a Library school student with a \$4,000 scholarship to partially cover tuition for their studies. The award is always well contested and this year was no different. Ms Chew Shu Wen was the well deserving recipient of this award. The presentation of the Scholarship will be held at the upcoming LAS AGM 2013

#### 8.2.5 LAS Special Librarian Passion Award 2012

The Passion Award was presented to Mr. Rajendra Munoo on Thursday, 1 November at the 3<sup>rd</sup> annual SLS Networking Event for his contribution and passion as a special librarian. He received a certificate and a \$300 cheque sponsored by LexisNexis.

This award was created to recognize one individual or group each year for outstanding contributions to the Special Libraries Section or any of its Interest Groups. Nominations were sought from LAS members and members of the SLS interest groups.

#### 8.3 LAS Overseas Library Professional Development Sponsorship

As part of the ongoing support for professional development, LAS announced the opportunity to apply for a subsidy of up to \$2,000 to attend an overseas library conference or other learning opportunity during 2012-2013. Applications were accepted through 15 January 2012 for conferences taking place up to 30 April 2013.

Ms. Foo Soo Chin was awarded sponsorship to attend the Australian Library and Information Association (ALIA) Biennial Conference 2012 held from 10-13 July in Sydney. Soo Chin shared her conference experience through an article in the Singapore Library Bulletin.

#### 9. Professional Development Scheme (PDS) Board

9.1 A total of 12 and 20 members submitted their PDS applications in July 2012 and January 2013 respectively. Of these, 11 members from the July 2012

- were awarded PP status after the examination of PDS Board and PDS Working Committee
- 9.2 PDS Board is in the final approving process for the batch of 20 applications submitted in January 2013.
- 9.3 To date, 10 reading circles from various institutions have been registered under the PDS.
- 9.4 As at March 2013, 68 members are qualified as Practicing Professionals under the PDS scheme.
